City of Williamsburg	This project will reduce erosion of the stream bank in the Walnut Hill community. Extreme weather events and heavy rainfall have caused the loss of trees and other wetland plants, which has increased nutrient runoff into the Chesapeake Bay. The continued erosion has been a cause of community concern for some time and has caused harm to existing real estate assets in the area.	City of Williamsburg VA	\$422
City of Danville	The Danville Riverfront Park Initiative would include rough grading, stormwater system drainage, sanitary sewer and water service, fine grading, retaining walls, and irrigation efforts.	Danville VA	\$2,500
Longwood University	Facility upgrades to preserve a building that is a National Historic Landmark and on the National Register of Historic Places.	Farmville VA	\$500
Frederick County Sanitation Authority	Lake Frederick is located south of Winchester, Virginia in the southern part of Frederick County. Potable water is supplied to this part of the County solely by a five-mile pipeline with no redundant pipes or backup water sources. This leaves one of the largest single communities in the area vulnerable to water main breaks or other supply disruptions. This project would provide an independent water source (well and treatment plant) within the Lake Frederick community, thus improving water reliability and increasing overall system capacity. It also supports regional infrastructure, as completion of this project would allow expansion of services in surrounding counties.	Frederick County VA	\$3,600
City of Norfolk	The West Ocean View Water and Sewer Replacement project replaces approximately 2500 linear feet of gravity sewer and water mains that were installed in the 1940s and 1950s in the West Ocean View neighborhood of Northside in the City of Norfolk.	Norfolk VA	\$2,343
City of Norfolk	The project replaces approximately 2600 linear feet of aging gravity sewer and water mains within the public right-of-way in a predominantly residential neighborhood of approximately 4200 residents adjacent to the Broad Creek and Elizabeth River waterways.	Norfolk VA	\$2,536
Town of Pulaski	Complete architectural and engineering design including comprehensive construction documents for the entire building (except the childcare center) and preservation construction activities in the entire facade and front section of the building.	Pulaski VA	\$500
City of Richmond	This project will investigate, design, and build the necessary infrastructure to treat the remaining combined sewer discharges from Richmond to achieve compliance with water quality standards. This will involve a combination of new storage facilities, tunnels, larger pipes, and greater treatment capacity at the wastewater treatment plant.	Richmond VA	\$9,200
U.S. Forest Service	The requested FY22 funding for the George Washington and Jefferson National Forests (GWJNF)-via the U.S. Forest Service, Land and Water Conservation Fund, Land Acquisition account-will allow the GWJNF to complete the acquisition of priority inholdings. The current parcels targeted for acquisition using these FY22 funds are: Dry Run Appalachian Trail (77 acres in Smyth County); Straight Fork (1,612 acres in Scott County); and Iron Mountain (104 acres in Grayson County). All three of these tracts would be incorporated into the Jefferson National Forest. The 1.8 million-acre GWJNF are located primarily in Virginia and expand into West Virginia and Kentucky.
